APPLICATIONS FOR SEPTIC PERMITS ARE REQUIRED TO PROVIDE THE FOLLOWING DOCUMENTATION.

- 1) Application completely filled out;
- 2) A site plan DRAWN to SCALE MUST include the following: (MUST BE SIGNED BY OWNER/AGENT)
 - a) Property dimensions;
 - b) Location of ALL proposed and existing residences and/or buildings;
 - c) Swimming pools;
 - d) Recorded easements (if you are not sure there are any, you will need to call recording to verify);
 - e) Proposed septic tank and drainfield location (must be drawn to scale, including 4' shoulders and slope);
 - f) The slope of property if applicable;
 - g) All neighboring lot's septic systems and wells (must show location and distance to your property); if property is unimproved state no septic no well on that particular property;
 - h) Surface water (ditches, ponds, streams, swamps, etc.);
 - i) Filled areas;
 - j) Obstructed areas;
 - k) Driveway and walkway from drive to house;
 - l) Location of your well (drinking or irrigation); must show route of water line into house;
 - m) If serviced by community water, show route of water line from meter to house;
 - n) Any public wells within 200' (city, motel, service station, restaurant, etc.)
- 3) Floor plan to scale; (SIGNED BY REGISTERED CONTRACTOR OR PROPERTY OWNER ONLY)
- 4) Application forms must be signed by registered contractor or property owner only.
- 5) A satisfactory water sample is required before a Certificate of Occupancy is issued.
- 6) Address verification form from Public Safety.

NOTE: SEPTIC SYSTEMS MUST MAINTAIN A 75' SETBACK FROM ALL POTABLE WELLS AND 50' FROM ALL NON-POTABLE.

NOTE: WE CANNOT PROCESS YOUR APPLICATION WITHOUT THE ABOVE INFORMATION SUBMITTED CORRECTLY WITH APPLICATION. IF ANY INFORMATION IS FOUND TO BE ERRONEOUS, IT MAY RESULT IN THE PERMIT BEING VOIDED, WHICH WILL REQUIRE A NEW APPLICATION BEING SUBMITTED.

EVALUATIONS ON EXISTING SYSTEMS \$85.00 (MUST HAVE SIZE OF OLD HOME AND DATE OF ORIGINAL INSTALLATION). Shed/pool detached garage 35.00

There is a 50.00 fee for all permits requiring an excavation inspection

BEFORE A REPAIR, REJUVENATION PERMIT OR AN EXISTING SYSTEM CAN BE APPROVED YOU MUST HAVE THE TANK PUMPED AND CERTIFIED BY A LICENSED SEPTIC CONTRACTOR AND DH 4015 FORM SUBMITTED TO THE HEALTH DEPT.
