- Flood Mitigation Assistance (FMA) FY 2019
 - o Identified for Further Review: 4
 - Awarded: 1
- Pre-Disaster Mitigation (PDM) FY 2019
 - Identified for Further Review: 4
 - o Awarded: 1
 - FEMA anticipates having all eligible sub-applications awarded by September 30,
 2020
- FMA FY 2020
 - o Total Available Funding: \$160 million
 - FMA NOFO, Fact Sheet and information on FEMA Go System has been emailed out, contact Laura Waterman or Susan Harris-Council if you did not receive them
- Building Resilient Infrastructure and Communities (BRIC)
 - Eligible Applicants:
 - States, Territories, Federally Recognized Tribes and District of Columbia
 - Sub-applicants: Local Governments, Indian Tribal Governments, State Agencies and Tribal Agencies
 - Individuals, businesses an non-profits are NOT eligible but a local government may apply on their behalf
 - Incentivize:
 - Public infrastructure projects
 - Projects that mitigate risk to one or more lifelines
 - Projects that incorporate nature-based solutions
 - o Increase funding to Applicants that facilitate the adoption and enforcement of the latest published editions of building codes
 - BRIC FY 2020 Uses of Assistance:
 - 33.6 million to State/Territory Allocations
 - 446.4 million for national competition for mitigation projects
 - Funding Caps
 - State Set-Aside: \$600,000
 - National Competition: \$50 million per sub-application (per project)
 - Cost Share
 - 75% federal / 25% non-federal
 - Florida Application Period:

- September 30, 2020 to November 12, 2020
- NOTE: applications are due to FDEM earlier than the FEMA deadline so that we can ensure applications are complete.
