Osceola County invites you to a public information meeting regarding the Westside Boulevard Extension Project on Wednesday, September 27, 2023. The purpose of this project is to determine whether and how to improve safety and provide a connection between an existing segment of Westside Boulevard to the north, at the existing terminus south of the Solara Resort development, and on the south near Barry Road adjacent to the Eden Gardens Resort. An additional southern extension to connect Westside Boulevard to the south will be designed and constructed by the development interests fronting the corridor.
