Following this framework ensures that a thorough evaluation of each project is completed before it is submitted for funding and all potential impacts are taken into consideration. The Project Scoring Worksheet is designed to assist the LMS Working Group with project prioritization by ensuring that projects meet minimum eligibility requirements and by providing a reference score derived from an analysis based on the established criteria. The score is to serve only as a reference for the LMS Working Group when prioritizing projects, and alone does not determine project eligibility or prioritization.


