## Standard Conditions of Probation

Pursuant to FSS. 948.03 Terms and conditions of probation. - (1) The court shall determine the terms and conditions of probation. Conditions specified in this section do not require oral pronouncement at the time of sentencing and may be considered standard conditions of probation. These conditions may include among them the following, that the probationer or offender in community control shall:

1. Report to the Osceola County Probation Office as directed and make a full and truthful written report to your supervising officer each month on the form provided for that purpose.
2. Pay the Osceola County Probation Office, the amount of fifty dollars **(\$50.00)** per month, toward the cost of your supervision. Payments accepted: money orders, debit cards, or major credit cards.
3. Remain within a specified place and do not travel out of state without **first** notifying your supervising officer.
4. Notify your probation officer immediately of any change in your address or telephone number.
5. Live and remain at liberty without violating any law. Any new law violation may constitute a violation of your probation. A conviction in a court of law shall not be necessary in order to violate your probation. If you have contact with law enforcement for any reason, you must notify your supervising officer within seventy-two (72) hours.
6. Unless prohibited from consuming alcoholic beverages by a special condition of your sentence, you will not consume alcoholic beverages to the extent that you become intoxicated.
7. Not possess, use, or consume any unlawful controlled substance. Controlled substances that are prescribed by a medical doctor may be used only in accordance with the legal prescription.
8. Submit to random testing as directed by your supervising officer or the professional staff of the treatment center where you are receiving services to determine the presence or use of alcohol or controlled/unlawful substances.
9. Maintain full time employment at a lawful occupation, or maintain full time student status insofar as possible, and support any legal dependents to the best of your ability.
10. You are prohibited from possessing, carrying, or owning any firearm unless authorized by the court.
11. Not associate with persons engaged in criminal activities.
12. Comply with all instructions given to you by the Court and your supervising officer. You will promptly and truthfully answer all inquiries directed to you by your officer and allow him/her to visit your home, your employment site, or elsewhere.
13. Satisfy all probation conditions and provide proof of completion to your supervising officer no later than thirty (30) days prior to the expiration of your probationary period.
14. In addition to the above, there may be other conditions imposed by the Court as part of your sentencing.

**If you violate any of the conditions of your probation, you may be arrested and the Court may revoke your probation, adjudge you guilty, and impose any sentence that might have been imposed before placing you on probation.**

I acknowledge that I have reviewed the above conditions. I further understand that it is my responsibility to comply with all of the court ordered conditions.
